SCC Spring Membership Meeting

Prior to the start of the official membership meeting, awards and recognition were presented for each league and club championships.

Meeting called to order at 7:16pm

Secretary's Report – Shevaun Stocker

Motion to approve Fall membership meeting minutes (Warren/Lund) – approved unanimously

Treasurer's Report – Tim Bradshaw

- Projected to finish the year ahead of budget
 - We budgeted a \$14,500 deficit; it's now projected to be about \$5,500 to \$6,500 deficit
 - \circ $\;$ Deficit largely caused by reinvestment into the club
 - 3 furnaces, 2 dehumidifiers, 1 water heater, parking lot light replacement
 - Junior program/membership saw an increase of \$1625 (+66%) from last year
- The opportunity
 - Non-junior membership dues saw a decrease of \$7,800 from FY 23 (-19%)
 - Non-spiel bar revenue saw a decrease \$3,140 from FY 23 (-19%)
 - Gross profit margin from the bar stayed on target of 60 to 65%
- Sponsorship advertising is recurring revenue (our sponsors stay with us for years)
- Current assets at about \$130,000 (up from \$92,948 in 2018), while also investing over \$100,000 into capital improvements the club over the last 4 years
- Prior to COVID in 2020, we were trending upward in membership; unfortunately, since re-opening the club in 2021, we are seeing a decrease in membership (though junior membership is up)
 - We have some work to do to build membership back up
- We also need to build our bar revenue
- Motion to accept the Treasurer's report (Lund/Bergquist) approved unanimously

President's Address - Mike O'Brien

- Financials overall, a successful year though we do have areas to work on
- Thank you's: Chris Warren (to move meeting offsite and include a celebration), the Board (4 of whom are finishing their first year on the Board), Rick Flesvig (all his many years of ice management), Chris Warren (taking over as ice manager)
- Dues have maintained for the last few years (we're less expensive than Duluth; about on-par with Two Harbors, depending on how many nights you curl)
- Dollars for Doers we increased the compensation for volunteer hours
- First year with the dehumidification system
 - Next Board will need to explore whether we should purchase a third one (the 2 weren't quite enough)
- Club management
 - The driveway is better than it used to be but we still need to continue working on the maintenance of it
- Bylaws are now updated and available on the website
- Lifetime membership policy was developed and now on the website
- Wednesday, November 6th we'll be hosting the CANAM Cup of Curling (likely around 1 or 2pm)

- We'll need players and we'll need hosts (Tuesday and Wednesday night; provide lodging, transportation to the Duluth and Superior curling clubs, provide breakfast each morning)
- USA Curling has a Club Council meeting once a month (provides guidance to clubs, listen to concerns from clubs)
 we are looking for reps for the SCC to participate in these; reach out to Mike if you're interested
 - \circ Second Wednesday of the month (may be less frequent in the summer)
- We have quorum thank you, everyone, for attending!

Club Manager Report – Scott Laven

- Furnaces & dehumidifiers cut down the run-time on the furnace by about 70% (and the clubhouse is warmer than it used to be)
- Some of the investments in the last 5 years include a new water heater, new lights in the ice area, new compressor, new mechanicals, new parking lot lights
- Made a deal with Daniel Litchke to keep putting more gravel out in the parking lot; maybe one day we'll have the funds to pave it
- Roof is going to need replacing (likely in the next 5 to 7 years); working on getting estimates this summer
 - Was probably last done in 1989
 - May be able to use volunteer assistance from the league?
