#### Treasurer's Report – Scott Laven

Financial Recap report on all tables for viewing. Scott discussed all points noted on the report. Noting:

- Net income for fiscal year as of 4/7/16 is \$13.575. After paying out some remaining expenses, we are on track to have a net income of ~\$10,000 compared to \$9,329 for last year.
- 151 members generating \$25,578 in dues.
- Bar net income was \$13,596 compared to \$7,443 last season. Thank you Wednesday and Thursday night curlers!
- Bonspiels generated a net profit of ~\$9,100 compared to ~\$9,000 last year. This is minus bar receipts. Bar sales profit was ~\$4,000.
- Unexpected major expense incurred were \$10,787 for compressor repairs.
- Unexpected minor expense incurred were \$500 for furnace and ice-maker repair.
- Upcoming major expenses none at this time.
