Review of results from email voting

- Worker's comp insurance we will move ahead with the \$621 per year option (6 votes for this option)
- Lifetime membership policy five votes for option 2, one vote for option 1 and one abstaining. Unless someone objects, we will accept option 2 adopt the policy last sent out by Doug with the modification that any nominee must have been a member in good standing for at least 25 years (they may or may not currently be a member)
- Learn to curl fee three votes for free, one vote for \$10 and three votes for \$20. I will make sure this is discussed further at the membership committee meeting tomorrow evening.
- Next meeting Six votes in favor of setting up this video meeting

Treasurer Report, including budget – Tim (Scott)

- Tim will have copies of the 2023-24 budget summary for the membership meeting tomorrow
- Looking at a deficit of ~\$8,704 (this is worst-case scenario), reflects recent expenditures
- Current budget is allocating 11% of dues we collect going to USCA; with the change in their membership dues model, that might change (we'd pay USCA less than what is current indicated in the spreadsheet)
- Will work on the audit once the season starts; tax returns will be filed sometime between now and November 15
- Motion to approve budget as presented (O'Brien/Runnow) approved unanimously

Ideas for honoring Bud Somerville – Doug

- One idea would be to designate a sheet in honor of Bud Somerville, engraving two rock handles (maybe the 7 & 8 rock on sheet B, for Bud), host a party
 - o Ideally in time for the CF bonspiel
- Could also rename the CF bonspiel in honor Bud, as he was important to getting that started
- Maybe put something in the ice?
- Need to reach out to Bud's family to see whether he is interested in any type of event
- Need to reach out to current members who may have curled with him see if there are things they think he'd especially appreciate
- Budget for this?
- Put a committee together that can finalize what we'll do Doug can head this (Kim Lund and Brian Bergquist may be interested in helping with it)
 - O We can't do benches not enough room on the ice
