SCC Board Meeting

Secretary Report - Shevaun

Motion to approve December board meeting minutes (Runnoe/O'Brien) - approved

Treasurer Report - Tim

- \$37k in checking account, plus \$105k in CDs
- Scott and Tim will meet at National Bank of Commerce this week to open another CD (5% rate) will probably be \$20k
 - May end some of the 2.7% CDs early to put into these 5% CDs
- Budget updated through Dec. 31, 2023; YTD, we're sitting at a \$27k net surplus
 - Dues income had to be adjusted downward (to \$33k, from \$40k in previous years)
 - Dragon boat brought in \$1k (thanks to Doug and Susan!)
 - We should be able to cut the check to Cystic Fibrosis Foundation soon, from the CF spiel revenue
- We should be careful in making any improvements to the club or ad hoc major purchases, since we will have less dues income than usual
- For the NW bonspiel, we historically allow the Canadian teams to pay on par, which means we lose several hundred dollars; should consider whether we want to continue this practice
- Budget audit committee should have their work done in the next few weeks
 - Question was raised as to whether the membership of the audit committee allows for board members to be on the committee
- Question on the budget spreadsheet for row 126, is that supposed to be 'bar re-sell'? Yes (Tim will get this renamed in Quickbooks)
- Question do we have enough electric/utility bills to see if the furnace replacement/humidifiers have led to a
 reduced cost? Tim not yet; we should keep an eye on it and if we're not seeing a reduction, we need to reach
 out to the fair board
 - Discussion about whether we have the right power meter set-up for our needs/usage; Mike may followup with Rick & Scott about whether revisiting this is useful
- Motion to accept the Treasurer's report (O'Brien/Stocker) approved unanimously

Triples League – Greg Gullicksrud

- See flier for details
 - Starting January 23rd, pick-up games on Tuesdays are an option in this Triples League (at either 3:30pm and 8:15pm)
 - Folks can sign-up as a team of three or as individuals
- Twin Ports Triples Challenge on Saturday, Feb. 24th see flier for details
 - A one-day four-draw event (need a total of 8 teams)

- We need to identify who will play in the challenge (teams of either 3 or 4 curlers so we'll need 12 to 16 players)
 - The commissioners of Mon, Tues and Wed leagues would organize the teams
- o Duluth and Two Harbors clubs will need to organize their teams
 - Alternatively, could just create an option for folks to sign up online and take the first X number of curlers from each club
- Registration needs to be figured out online?
- Still need to identify food plan (and arrange bartender), player recruitment/communication plan, volunteers (kitchen/bartender/ice), ice prep for the day (Greg is trained to pebble; would need someone from the ice crew who can do more extensive ice prep)
 - Plan to charge each player the cost for food; the board encourages a price that ensures the club doesn't lose money (maybe \$20 per player? Maybe more?)

- Flier is done; will go out to membership via email and posted to FB for members to share
- Sent out to news websites, school
- Need to recruit instructors
- Shevaun ask Joe to send to sponsors to have them share it with their employees
- Future membership recruitment idea get a contact at Superior city hall to try to advertise the club with city employees

Dollars for Doers - Shevaun

- Needing to notify membership about change in amounts (Scott can this get sent to membership?)
- Tracking ideas Shevaun and Scott will converse this week about this

Lifetime Membership - Doug

- Doug is putting together a committee (Brian feels like it would be a conflict of interest if he's on the committee, since he was involved in the nomination of all three nominees)

USCA Club Council Meeting (Jan. 10th) Update – Mike

- Training for Level 1 and Level 2 instruction USCA said to reach out to Lauren at USCA to coordinate the training we need
- Insurance it looks like we can save some money on our liability insurance (USCA has a \$3million liability insurance policy that is bigger than what we're currently paying for; has a \$1k deductible)
 - It's automatic as long as we're USCA club members
 - o If an individual player is a USCA member, it provides some medical insurance
- Info about Junior curling there is information on the USCA website that may be helpful; Mike shared this with Doug
- Mike's take-away- the USCA website has a content platform that may have useful information for us

Ice Manager – potential replacement

- Mike and Scott have been approached by the Duluth club about doing a combined ice crew
 - Superior would provide a person for each night from the Superior club who would handle the nightly prep; Duluth could provide the overall management
- Mike has discussed the ice manager position with Chris Warren and hasn't gotten much interest from Chris
- Mike will discuss with Rick what Rick's ideas are for moving forward with this position
- It may be time to put an Ice Management Committee together to:
 - Create list/description of tasks, by time of year
 - Brainstorm ice maintenance models
 - Brainstorm members who could be asked to take on ice prep roles (for whichever model we end up going with)
